 - ✓ In many other parishes if you call 911, like in East Baton Rouge if you are sign up with SMART911 it will pull up your information right there in front of the operator
 - ✓ Its like that in some other States as well
 - ✓ If anyone is interested in someone from the 911 office to come out and talk to a certain group or church, just give them a call and they will do that
