- Gerald, Recognition to Dick for getting the CAER back up and running again. Mason and Gerald will get a letter typed up and send it to Bryan.
- Dick, LAIA will have a committee meeting tomorrow Wednesday, and will discuss the four procedures for the CAER notifications, to make sure everything is the same wording on each form.
- Participation has been really good from the LAIA.

- *Dick, Lloyd will be talking to the CAER members in the future about switching to a different radio frequency, it will most likely be the 700 system. Some members don't have that capability but will work with them*

- **Treasury Report: \$86,556.84**

- **Communications Update:**

- ✓ *Rob, At the last 911 board meeting they discussed that between 96% of all the 911 calls are from a cell phone and not a landline.*

- **Incidents:**

- ✓ *Rob, Was called over the past weekend for a missing girl that had gotten into trouble and they wanted a ring down done, but before that happened the girl used her cell phone and drop pinned her location and sent it to her mom and they were able to find her.*
- ✓ *Sean, They had a rollover near Welsh the last two weeks that had the interstate shutdown for about 12-15 hours for cleanup.*
- ✓ *Jerry M., Ward 7 had a major wreck on the interstate near the scales, with the driver not making it out the fire of the truck. They had to Mutual Aid Vinton Fire, Sulphur Fire to the scene and called on Lake Charles Fire Dept. to stay by the station in Vinton and take any calls for them, and Carlyss was the next on the list to call out. It worked and showed Mutual Aid is working.*
- ✓ *Keith, They have been getting called out to a Barge fire that is tied up off of Goos Ferry Rd. because of someone taking the scrap metal from it and starting a fire, now they have DEQ, Wildlife and Fisheries, and U.S. Coast Guard involved. Hope to see some results in the near future.*

- ✓ *Rob, No drills as of this time, but the industries have been doing in house drills in their facilities*

- **Tier II:**

- ✓ *Still waiting on six facilities to file with the State their 2013 Tier II reports, I did send Sean LaFleur the six facilities information but haven't heard back from him.*

- ✓ *Mason, Has sent a letter to Gene Dungeon with the State Police regarding the Tier II facilities that have not filed yet*
