✓ **Presentation by DOTD: Todd Landry –**

- **Todd Landry, LA DOTD, 337-491-9100**
- *I-210 Bridge Rehabilitation Project*
 - *Bid Date: January, 2016*
 - *Est. Cost \$20-30M*
 - *Construction length: 24 Months*
- *They will be changing out the main span of the deck, and also will be putting lights up on the bridge also in this project*
- *Will have 5 message boards throughout,*
 - *Near Hwy 109*
 - *Hwy 165 coming Southbound*
 - *Hwy 165 going Westbound*
 - *Hwy 171*
- *Phase 3 of the project will be installing cameras on the bridges*
- *2017/2018 for maybe the I-10 bridge but still not sure because they are still in the Environmental stage*
- *The laydown yard depends on the contractor and not sure at this point where it will be at*
- **Construction Review**
 - *Project will include replacing the existing deck on the main spans and establish a positive connection between the new deck and the supporting girders*
 - *Additionally, a safety inspection walkway will be installed under the bridge to make all future DOTD bridge inspections more cost efficient and less disruptive to traveling public by reducing the need for future lane closures*
 - *Add inspection walk at of each of the 4 main girders in order to ensure accessibility to the deepest segments of the main spans. It will also provide for an effective means of performing maintenance and rehabilitation of the main spans.*
 - *Existing rails will be replaced on both bridges with the most current crash tested bridge rail*
 - *Centerline between the 2 bridges, the new cross section will provide a narrow but continuous paved walk. It will enable access to the light poles as well as access to the pier entry points.*
 - *Also replacing of the slabs, wing walls (some are broken) and bridge railing*
- **Traffic Control**
 - *The main concern will be that there will be two-way traffic on one side of the bridge with a concrete barrier in the middle*
 - *Moveable barriers, Contraflow and Variable message signs*
 - *Plan on being able to get cars out as fast as possible with the moveable barriers and using contraflow for emergency situations*
- **I-210 Lighting Project**
 - *The start for the lighting project December 2015*
 - *Completion Date: December 2016*

- *Cost: \$2.6M*
- *The current lighting project will complement new lights which will be installed during the redecking project.*
- *Stakeholder Outreach*
 - *Coordination with Law Enforcement and Emergency Personnel*
 - *December 3, 2015 at 9AM in the DOTD Conference Room at their Region Office in Lake Charles, LA*
 - *Will also be having a Public Meeting soon also in the month of February*
 - *Motorists can also use MYDOTD/Way-2-Geaux/511 apps for any information that is available*
 - *The MYDOTD can be activated online by visiting www.dotd.la.gov*
- *Gerald Pullin, with CAER coming by together, can LEPC get with the NWS about getting a letter from them for being able to use the weather bands for emergency situations*
