New Projects: (Gerald Pullin)

- World LNG Conference at George R Brown convention center Houston, May 31 - June 1. 12 LNG companies attending.
- Projects now being considered for SW Louisiana and SW Texas in next 30 months total \$171 Billion and now Anticipate needing over 50,000 construction workers.
- Sempra LNG Port Arthur \$10.5 Billion 100 permanent, 8,000 constructions. Final investment has been done, contractors are Bechtel and Zachery.
- Golden Pass LNG Port Arthur \$10 Billion 3,500 permanent, 8,000 Construction.
- Driftwood LNG Carlyss \$16 Billion 400 permanent 9000 construction. Bechtel and Bo Mac on site now.
- Lake Charles LNG \$10 billion 8000 Construction. Energy Transfer expects FID in Q4 2023.
- Chevron orange \$8.5 Billion 100 permanent 7000 construction. Contractor bid pkgs being sent out now.
- Chenier LNG applied to FERC for more production capacity construction.
- Exxon Mobil Beaumont \$6 billion 1000 permanent 2000 Construction.
- OCI methanol Beaumont \$5 billion 100 permanent 3000 construction.
- Valero Port Arthur \$3 Billion 400 permanent 2500 construction.
- Entergy Bridge City \$5 Billion 200 permanent 2000 construction.
- Arbor biofuels Beaumont \$3 billion 200 permanent 1500 construction.
- Venture LNG CP2 project - McDermott GC sending out bid pkgs. SCG&E site on Monkey Island now location for Vesture LNG CP2.
- Tellurian purchased G2 zero net LNG on Monday February 27. Tellurian now owns Driftwood and G2LNG. Additionally sold to a company in New York, but now they have leased it back and will pay with their operational budget.
- \$2.1 Billion Delphin LNG ship under construction. The process is Black & Viech. GC not announced.
- Commonwealth LNG waiting on one more FERC signature to release \$60 million contract for site prep. Anticipate release second half of March 2023.
- \$8 Billion Chevron Orange has Kiewit, Burns & Mac, Zachary and S&B working on scope and bid pkgs.
- \$10 Billion expansion by Bechtel at Port Arthur LNG mobilizing with office trailers and equipment.
- \$1.5 Billion carbon capture project Cameron LNG to Hackberry strategic reserve for injection.
- \$4.5 Million Air Products Port Arthur Carbon Capture.
- \$98 Million mill and wood yard expansion in Hodge Louisiana by West Rock.
- Greenfield sawmill construction planned for Bon Weir.
- State of Texas biofuel project to provide jet fuel to LAX, to be built in Bon Weir waiting on permit approvals.

- LG Chemicals purchased 200 acres in Port Arthur for industrial construction.

XI. **Incidents:**

- (USCG) Received a call regarding a burn in Cameron Parish Sunday afternoon, USCG went out to investigate, and found that it was in the wetlands. Cameron FD responded to the fire, Cameron OEP was notified as well. It was crude oil, about 90 barrels. They just had to burn it off.
- (CFD) Conjunction with LSP Sunday night two storage units were struck by lightning. Called for Mutual Aid from HRFD, and W6FD. Everyone worked very well together.
- (LSP) Starks incident, Hwy 109 crude oil that got into the roadside ditch
- Biolab incident, A brief SIP was in effect, LSP commander was on scene, with other agencies. There were questions of where the incident was coming from, after looking at video footage, it was determined to be Biolab. I-10 was closed in both directions. Westlake did pressure one of their lines, and it went down fairly quickly. When it was determined that it was Biolab, it was hard to get in contact with personnel at Biolab. LCMH did have citizens coming into the ER with exposures. LSP troop initiated the hotline notification.
